This year Agrarian Trust launched the FaithLands Initiative program; hosting a national convening in California that brought together national leaders from across the country and developed a network aligned around shared values and goals centered on farmland. The FaithLands Initiative also carried out a pilot project in North Carolina focused on GIS mapping of faith owned lands, outreach and education to faith communities and farmers, and linking farmers to farmland.

The Agrarian Trust launched the Agrarian Commons committee. The 2020 committee, composed of founding farmers, community stakeholders, and Agrarian Commons Founders, localized these documents, refining legal language that covers the following topics: Farmer equity and tenure security with equitable lease/ground lease. Agrarian Commons 501(c)(2) and 501(c)(25) bylaws. Cultural respect easements. Legal language to prohibit market-based sale of land. Options to ensure active farming and stewardship. Farm standards, forest standards, and ecological-stewardship standards and agreements.
